The District and CCFT agree to the following:

- 1. Evaluations regularly scheduled for 2020-2021 will be shifted forward one year. Future evaluations will also be shifted forward one year.
- 2. Evaluations that will proceed on their current schedule for the 2020-2021 academic year will be:
 - a. Evaluations deferred from the 2019-2020 academic year to 2020-2021.
 - b. Full-Time Tenure Track evaluations.
 - c. Part-Time Faculty teaching in their 1st or 2nd semester.
 - d. Off-Cycle Evaluations.

The terms of this MOU are non-precedential and do not create any historic practice.
