# High School Student Opportunity

Earn college credit during the high school day through Cuesta College's College and Career Access Pathways (CCAP) Program – for free!

### WHAT IS DUAL ENROLLMENT/CCAP?

Through dual enrollment partnerships, school districts and community college districts create clear pathways of aligned coursework that allow students to more easily and successfully transition to for-credit, college-level coursework leading to an associate degree, transfer to the University of California or the California State University system, or to a program leading to a career technical education credential or certificate.

Dual Enrollment is an opportunity for high school students to concurrently enroll with Cuesta College, while in high school, for no enrollment fees.

# DUAL ENROLLMENT PROGRAMS AT CUESTA COLLEGE:

#### 1. Enrichment Program:

- Attend Cuesta College in person or online, outside of your student's high school day
- Enrollment fees are waived

### 2. College and Career Access Pathways (CCAP) Program

- During your student's regular high school day in their high school period
- Receive both high school and college credit for one high school period
- Student fees are covered
   (Enrollment fees, campus fees, instructional materials including books)

# THINGS TO CONSIDER REGARDING DUAL ENROLLMENT PARTICIPATION:

- Enrolling in college courses creates a permanent college transcript
- It is the student's responsibility to adhere to course specific deadlines, including dropping a course before the Drop Deadlines, when needed
- Parental involvement will be significantly different for the college component of the dual enrollment course which is governed by policies of the community college system. The Family Educational Rights and Privacy Act (FERPA) prevents higher education officials and instructional staff from releasing information about a student to parents, family, or others without a written release from the student, even if the student is a minor. This will limit parental access to student information and records with Cuesta College



# PARENT RESPONSIBILITIES OF CCAP HIGH SCHOOL STUDENTS:

 One time Parental Approval for your student to participate in Dual Enrollment (CCAP and/or Enrichment) during their entire time in high school

Once your student initiates the Dual Enrollment Permit to Enroll Form online, you will be notified via text message to provide parent consent to participate. Additionally, Paper Permit to Enroll Forms are available if needed.

Once a student completes the CCAP Enrollment Steps, Cuesta College will register the student for the Cuesta College course. More detailed enrollment information can be found here: bit.ly/cuesta-ccap-enroll

## DUAL ENROLLMENT/CCAP STUDENT RESPONSIBILITIES:

- Students must follow through on the Enrollment Steps outlined for the course to receive college credit
- Students who participate in Dual Enrollment with Cuesta College will receive a grade on a high school transcript, and a Cuesta College transcript
- Students are also responsible for adhering to Cuesta College course-specific deadlines such as the Last Day to Drop from the Cuesta College course
